# Chairperson's Report 2018

2018 marks the 25<sup>th</sup> Anniversary of the founding of UTASS, something for which we can all feel very proud. During that time, UTASS has grown and gone from strength to strength. We need to make sure that the next 25 years will be as productive and purposeful as we face up to new challenges.

For a charity like UTASS, raising funds is always a priority. In June we waited with bated breath to hear whether our application to The Big Lottery had been successful, particularly as this funding source has over the last few years provided a sizable proportion of our core costs. We were very grateful to have been awarded some funding again, although this time it will be for four years, rather than the five we had hoped for, and it will be tapered downwards over this period. We have also been told that this will be our last grant from this source. The amount received from The Big Lottery includes money to investigate sustainable funding for the future. UTASS has engaged the services of Rose Regeneration, who have been closely involved with us in the past, to help us explore this possibility.



To mark our 25<sup>th</sup> Anniversary, we were jointly invited to host a celebratory event in September for the Prince of Wales at Kirkharle Hall in Northumberland. Representatives from UTASS staff and membership travelled up to Kirkharle and were honoured to meet the Prince who took time to talk to us all and cut an anniversary cake, beautifully made and iced by Emma Spry.

Another occasion to mark our Anniversary took place at Raby Castle in November, by kind permission of our patron Lord Barnard. This enjoyable evening was organised in partnership with the County Durham Community Foundation. Potential sponsors were invited on tours of the Castle, and these were followed by a series of mini-interviews led by Caroline Theobald with

UTASS members. These gave an insightful and personal angle on the range of services and support that UTASS provides.

Closer to home, a very successful social evening with a hog roast was held at the Mart in August. The event was attended by 250 UTASS members and their families and was judged a great success, so much so that it is hoped that it can become an annual event.

We were very grateful to have been chosen as one of the recipients for the money raised by this year's Durham Shopping Extravaganza in October which raised a very generous £8,400 towards the work of UTASS.

The Christmas Fair, held in November at the Mart, was particularly well attended, with a wonderful range of varied stalls. Many people took advantage of the chance to stock up on Christmas presents, as well as enjoy refreshments provided by the Middleton scout troop.

Heartfelt thanks go to Mike Bettison who provided the entertainment following the AGM in June and had us all singing along to some well-known songs from 25 years ago, that took us on a trip down memory lane.

As ever, UTASS continues to provide services to the wider community, continuing with its provision of Post Office services, food bank facilities and providing a venue for occasions as diverse as Pilates sessions and meetings on local policing. On a theatrical note, we were the venue for two events in the Rural

Highlights programme- 'Jack and the Beans Talk' and 'Our Frances', both of which were well received. The theatre group also organised a sell-out visit to see 'Jersey Boys' in March and 'Miss Saigon' in October at Sunderland Empire Theatre.

In September we had stands at Wolsingham and Eggleston shows, which gave us the opportunity to meet members new and prospective.



Youth work continues to be a core part of UTASS services and, as part of the re-evaluation for the Investing in Children Award, we were told that

"UTASS is an outstanding example of how youth provision should be delivered." We were delighted to receive the award again. Other activities for younger members have included a visit to Grassholme reservoir in June, to go sailing thanks to Teesdale Sailing Club and some very popular evening sessions with

On the staffing front we were sad to say goodbye to our longstanding Chairperson Dr Jonathan Nainby-Luxmoore, who retired from Middleton



# Project Manager's Report

*On behalf of our dedicated, caring and hardworking Staff, Trustees, Volunteers and Patrons we are again delighted to report on work we have been involved in for public benefit throughout 2018, which included:*

- Practical support with the completion and submission of complex forms and paperwork, including awareness raising.
- Production and dissemination of regular briefings consisting of essential information distilled and de-jargonised from Defra, EU etc. and predominantly pertinent to the running of livestock based farm businesses.
- In cases of severe hardship, acting as third party referrers to organisations which include ARC Addington Trust and RABI.
- Support and training in setting up of sustainable methods of dealing with on-farm paperwork, including the computerisation of records.
- Twice weekly sessions for children and young people.
- 4 x Community Newsletters.
- Various training courses based on locally identified needs.
- Monthly Retired Farmers lunch & social sessions in Barnard Castle, Middleton-in-Teesdale and St John's Chapel.
- Advocacy and liaison work with local Landlords, Defra & other agencies.
- Lamb Bank, Sales & Wants and Labour/Skills List development work.
- Organisation and delivery of social & community events.
- Theatre Group organising trips to local theatre presentations.
- Topical presentations & awareness raising events
- Seeking feedback on consultations at local, regional & national levels.
- General drop in and telephone advice on a range of issues and signposting to other helper organisations & agencies.
- Provision of venue & outreach facilities for a range of agencies & organisations including Citizens Advice County Durham, Alzheimer's Society and Durham County Carers.
- Provision of facilities for Pilates and yoga sessions, chiropody and community meetings.
- Facilities for advertising local businesses/services/community activities and events
- Internet access, photocopying, faxing and laminating facilities.
- Support with the organisation and provision of annual local agricultural shows.
- Administration and collection point for the N E First Credit Union.

- Distribution of the Parish Councils dog poo bags.
- Provision of minibuses for community use and training.
- Music & Memories sessions for the first part of the year, cessation of funding prevented their continuance.
- Teesdale Heritage Group and Wear & Tees Farm Watch operated under the umbrella of UTASS.
- Provision of Post Office Services twice a week.
- UTASS took over the Oil Buying Group in February and it has grown from 130 to over 280 members who benefit around 2.5p per litre discount.
- Book exchange.
- Host Police “Drop-in” surgeries.

In 2019 we hope to develop the following

- Social outings for ladies to complement the well-established Retired Farmers Lunches.
- Closer ties with other community groups in the village and explore how we can work together.
- Work in partnership to develop a dementia friendly village.
- Re-introduce the Music and Memories Sessions.

**Out of Office Help** Thanks to Volunteers we were able to continue offering year round, **24/7** out of office support for those with urgent needs.

## **Basic Payment Scheme work**

After the 2017 experience, members were asked to make an appointment in advance of the application process to check the accuracy of the information held online by the RPA, particularly field data. This did throw up a number of anomalies from incorrect boundaries to missing “land parcels”, but it did give us the time to submit RLE1 forms and maps showing the correct information. This enabled the RPA to update their information ready for when the application window opened. As a result, the application period passed relatively smoothly with a much reduced need to complete RLE1 forms with annotated maps and fill “continuation booklets” in the run up to the deadline for submissions.

Paper forms were available if necessary, and the drop in centre at Carlisle was used to deliver forms and obtain receipts once again.

During the summer the RPA has made significant progress in processing the innumerable BPS Query forms that UTASS has submitted on behalf of its members over the last three years. Invariably this has led to the cancellation of penalties and additional payments to our members (by BACS straight into their bank accounts so we have little knowledge of the total amount). One of the payments, covering several years of under payment and penalties, has totalled over £60,000.

The RPA has also implemented the findings of the Minchinhampton Judicial Review in relation to the calculation methods used by the RPA to apportion BPS payments for claims including common and shared grazing. This has resulted in the award of additional entitlements and payments to our members. UTASS has been notified of over £136,000 received by our members so far.

**Graziers Groups** We continued to support and develop **6** Graziers Groups. The **6** Graziers Groups are due to receive **£3,780,750.00** amongst them between 2011 - 2021. Richard attended a meeting with Natural England and Moorland Association re a voluntary suspension of rotational burning on blanket bog for all the HLS agreements that are held. This is a temporary fix to avoid EU infraction proceedings until new 25 year Moorland Management Plans can be put in place.

**UTASS Membership** At the end of 2017 our member household mailing list stood at **482** addresses which is an increase of **12** households from last year. This membership consists of **416** farms and **66** other households/agencies/organisations - totalling **1446 members**. On average we received a new membership application every month.


## Contact Monitoring Data

**25465** contacts (27239 in 2017) resulting in **27,328** presenting issues (29133 in 2017).

Again in 2018 the most popular support area was administration support, including assistance with form filling, faxing, emails, photocopying etc. **20295** instances reducing from 22170 in 2017.

## Economic Benefits Gained

Based on conservative assumptions of errors prevented and associated penalties avoided.

### Quantifiable Economic Benefits Gained Included

- Direct assistance with BPS forms given to **200** farm businesses (**7 more** than in 2017) and the average basic payment of **£18,525.00** equates to approximately **£3,705,000.00**
- Direct assistance with BPS forms given to **207** farm businesses. Assume an average Basic Payment of **£18,525.00**. Assume 20% 'minor' mistakes with 10% penalties equates to **£74,100.00** For those farmer members who have agri-environmental agreements - cross compliance penalties would also apply.
- Support on cross compliance if based on 5% of our membership being inspected and receiving penalties equates to over **£38,532.00**.
- Businesses supported in the transfer of land and entitlements **£34,000.00**.
- Support given to numerous members with Environmental Stewardship Schemes (ELS, UELS & HLS) including applications equates to a minimum **£4,150,000.00** over the 10 year duration (2010 – 2020) of HLS with UELS.
- Support given with **25** Hedgerow & Boundary grant applications, average £10,000.00 each, equates to **£125,000.00**.
- Assistance to members with electronic applications for cattle passports, if assuming 5% of our membership would miss a deadline without our intervention, which would require them to pay for the dam and the calf to be DNA tested – this would amount to a minimum of **£3,434.00**.
- Based on 50% of UTASS farming members being Farm Assured, each farm selling 200 new lambs, 50 old season lambs and 20 beef animals equates to a minimum of **£471,432.00**.

Using the Social Return on Investment Model (SROI) - independent evaluations of the impact of the work of UTASS, undertaken by Rose Regeneration in 201 it showed the following returns for every **£1** invested:

- Basic Payment Scheme work **£7.47**.
- Young people's drop in **£8.97**
- Out of hours service **£8.77**.
- Music & Memories activities **£12.11**.

## **UTASS Calendars and Cards**

Together with the 2019 UTASS Calendar and Christmas Cards, this year, at the suggestion of a member, we introduced a general purpose card.

A big thank you, both to all who donated the photographs for the cards and Calendars free of charge, and also to all of the kind sponsors who generously covered the production costs.

This meant that every penny made helped to fund the work of UTASS

## **Briefings**

A continuing key part of our service is our briefings to members, which aim to give as simply and concisely as possible the essential information distilled from the reams of publications and books emanating from DEFRA. Failure to comply can be costly as support payments can then be subject to penalties. Our goal is to help our members to get all the support payments that they are entitled to. Again in 2018, 5 briefings were produced, covering a wide range of topics including Brexit, Annual Sheep & Goat Inventory, BPS, Hedgerow and Boundaries Grant Scheme Countryside /Environmental Stewardship, Countryside Productivity Small Grants, Postal Fraud, Government Consultations, Making Tax Digital.

## Training Provided

Responding to requests from community members we organised relevant training courses, delivered them locally and sought funding on behalf of trainees wherever possible, whilst relying on minimum numbers to run. This year the demand for Shearing training was such that 4 days of shearing training was held, with television cameras filming for the Yorkshire Vet programme on one of the days. Thanks to Warrens Group for help with funding this training. Please see details of all training delivered at Appendix 1 on page 30.

Funding for young people's driver training provided opportunities for Lantra 13-15 Tractor Driving, Pre Test Tractor Driving, Quad Bike, Car Lessons & Trailer lessons, with thanks to the Wellesley Trust Fund at The Community Foundation Tyne & Wear and Northumberland and to The Hedley Foundation. Comments from trainees have been very positive "The best day so far this year." (after completing Lantra tractor driving). Regarding trailer training "I am very pleased with the outcome! Thank you for

allowing me this funding so I could do this.” “That’s brilliant thanks so much for your help.”

“Thank you for this bursary it’s really helped me 😊”

Two years of part funding for trainees provided by Weardale Action Partnership came to an end. Our second application was successful with the first training, NPTC Rough Terrain Telescopic, being held in November, with a wider range of courses available. We have also been able to deliver two Emergency First Aid courses, an 8 week “Creating Resilience & Emotional Wellness” course with Mind and have just started CMI Management Training which will run for a year, with training days once a month.#

We were delighted to be chosen in 2017 as a partner for the delivery for the Prince’s Farm Resilience Programme. 15 farm businesses benefited from the workshops which ran throughout 2018. HRH The Prince of Wales met with some of those from the programme.

## UTASS Rural Watch “What’s App” Group

After some widespread identity theft in the early part of the year, UTASS set up a “What’s App” group intended to act as an early warning system. Though not a means to report crime, Barnard Castle Police are part of the group and benefit from the information contained there and also use the group to pass on information regarding arrests made etc. The group now has over 100 members.



## Computerised Farm Records and Agricultural Secretarial Work

Farm records continued to be maintained on behalf of a number of businesses in the Teesdale area including two new farms. The requirements for recording sheep movements changed at the start of 2018 and greater detail required for the movement of animals required. Temporary Land Association and Temporary Holding number applications made in 2017 required renewing.

Hedgerows & Boundaries Countryside Stewardship Grants were popular with our members as the upper limit was doubled to £10,000.00 and many applications were successfully applied for as well as grants for livestock handling facilities.

Emma Spry and Charlotte Fletcher completed their training with the Institute of Agricultural Secretaries and Administrators (IAgSA) in 2017 and initially shadowed Richard and Tessa with BPS, mapping and general grant/scheme agreement work. As their confidence grew they began to assist with the less complex under the guidance of Tessa and Richard.

## Lamb Bank, Sales & Wants & Labour/Skills Lists

Lamb Bank, Skills & Services and Sales & Wants schemes continued to operate, however the need wasn't as apparent as it had been in previous years.

### UTASS Minibuses

Our community minibuses were used in 2018 by **25** local organisations on a not for profit basis. User groups included Middleton-in-Teesdale Primary School, Old Forge Surgery, Cardiff Ramblers, St Mary's Parish Church Barnard Castle, Middleton-in-Teesdale Christmas Lights, and the AONB.

The buses were used to transport people attending the music & memories sessions from local care homes.

They are regularly used to bring Young People from the isolated Upper Dale to socialise with their friends at the weekly Drop-In session. On **6** occasions they were used to transport Young People to offsite activities, such as sailing, paint balling and indoor climbing.

In 2018 we took a number of farmers attending one of our CREE lunch sessions to the Weardale Museum in Ireshopeburn. In 2019 we would like to pursue this concept with visits to other attractions. We also hope to commence similar visits for ladies.

# Work with Children & Young People

## Young Peoples' Facilities:

Sessions provided much needed social facilities on weekday evenings, some weekends and during school holidays. Many of those living on remote farms were transported to and from activities in the **UTASS minibus**.

The Young People continued to play their part in the management, development and financing of their project and we achieved **Investing in Children** status for the **13th** year running. The assessor concluded:

**“UTASS is an outstanding example of how youth provision should be delivered and as always it is a pleasure to visit to meet with the young people and staff from the project to hear about the positive contribution young people make to the service.”**

We worked with Investing in Children on various topics, Time to talk and taking part in their Questionnaire's.

A total of **115** Young People (**51 female and 64 male**) accessed Drop In and Youth Club at UTASS.

Sessions were delivered weekly throughout the year on Monday and Thursday evenings. Thursday evenings were the most popular with an average attendance of **40** Young People aged 8 – 12 years? An average of **20** Young People aged 8-14 years attended the Monday Night Girls Group. Wednesday evening sessions were mainly offsite to local parks or places of interest.

We were very grateful to receive funding from Teesdale Action Partnership for youth workers for the 13 – 19 age group, and The Mental Health Local Care Concordat provided funding to convert a storage space into a room for use primarily by older young people. On the 3<sup>rd</sup> of May 2018 we were able to resume with an open night in their new room with 22 young people attending.

A VAT registered “Special Purpose Vehicle” established in March 2013 by UTASS to facilitate the North East Rural Growth Network (NERGN) grant funding/investment offered for our locality. Registered office is 9-11 Chapel Row, DL12 0SN.

Throughout 2018 four Directors, Bob Danby, Diane Spark, Carl Stephenson and Ian Tallentire, have overseen the Community Interest Company with significant help from staff and volunteers at UTASS.

DDECIC entered year 5 of a 5 year Agreement with Middleton-in-Teesdale Farmers Auction Mart for the management of the 4 business units in the Aspire Building on the Mart site. Meetings between DDECIC and the Mart to explore management options beyond August 2019 have taken place and will continue in 2019.






